Islamic extremist group supported by powerful politicians committed Sinhalese Genocide

Introduction

One of the national newspapers disclosed that on the 26th of May 2019, a Muslim gynaecologist in a Teaching Hospital in Kurunegala sterilized 8000 Sinhala women against their will. Powerful Muslim politicians objected to the news article and issued statements supporting the gynaecologist protecting him from accusation. The said gynaecologist was a member of the powerful Muslim politician's party and had contested in a general election under the name of a major affiliated political party. The government did not take strong actions to investigate the allegations as the Government depends on the slender majority vote of the Muslim Members of the Parliament that belongs to the powerful Muslim party. So far, nearly 500 written complaints had been logged by victimised unfortunate Sinhala mothers against the gynaecologist. However, the powerful Muslim politicians and Ministry of Health Department are prima facie avoiding and obstructing the investigations.

Genocide in the world?

In the past century there have been numerous genocides taken place in the world. From 1915 to 1922, Muslim emperor Ottoman had genocide Armenians from 7 hundred thousand to 1 million. From 1932 to 1933 in Soviet Union, Joseph Staling had genocide Kulakas 7 hundred thousand through food deprivation. From 1933 to 1945, Adolf Hitler had genocide Jews from 5 to 17 million using numerous methods including sterilizations against the will of women. From 1975 to 1979, Khmer Rouge leader Pol Pott genocide around 15 thousand Buddhists in Kampuchea. In 1994, around 8 hundred thousand Tutsi were killed by Hutu in Rwanda. Except in Rwanda, all other genocide incidents had happened under the leadership or support of the ruling party. In Rwanda, the powerful minority had attacked the majority through long term planning. Majority of the killing had been done using swords, knives and the like.

Similar to the Rwanda, the genocide victims are of the Sinhalese majority. Muslim are a minority in Sri Lanka and Muslim gynaecologists systematically sterilized the majority of Sinhalese women amid caesarean surgeries.

What is genocide?

International Criminal Law sterilization of women that belong to a selected nation by other nations is termed as genocide. The International Convention for Prevention and Punishment of Crime of Genocide treaty was introduced in 1951 January 12 by the United Nations under the proposal number 260 of the session held on the year of 1948. Out of the five methods of genocide mentioned in the treaty; the use of unlawful methods to control births of some nation is termed as genocide.

Dr. Gregory H Stanton (1996) had identified 8 essentials to committed genocide. Those are (1) Classification (2) Symbolization (3) Dehumanization (4) Organization (5) Polarization (6) Preparation (7) Extermination and (8) Denial.

How have those essentials been implemented against the Sinhalese by the Muslim?

Classification is identification of nations that need to be genocide by the assassins. The classification will be either religion or race. In this case it is the Sinhala Buddhist. For this purpose, Muslims have selected the Sharia Law, Arabic Language and burka cloths.

Symbolization is the use of different symbols to identify the assassins and others. In this case, the use of the Arabic language which is not a recognized language by the constitution, naming of streets in the Arabic language, use of Arabic names to housing schemes, use of halal mark, use of Arabic clothes etcetera will fall into this category.

Dehumanization is to classify the nation that is subject to genocide as inhuman, assassin nations and are supreme. There is plenty evidence from the Eastern province that include a clandestine radio channel that proscribed recently, a confession by a Muslim youth who was subject to be a suicide bomber along with many other publications that circulated through social media. The sentiment of the aim is to justify the killing of the dehumanize nation for a better world by removing the devils and attaining a status of holiness. Similar beliefs had been taught by Nazis in genocide of Jews and Hutus in Rwanda.

Organization is to prepare a group to perform the task. For this purpose, building of infrastructure and logistics including funding, head hunting and building strength, safe house, training facilities and transportation will be developed. There were huge amounts of money found in safe houses and hundreds of swords, knives and axes found in mosques. Similar to Hutu Power in Rwanda; using the name of "Jamaith" several clandestine military groups had been formed. The gynaecologist who sterilized Sinhala women was also a strong member of one of the Jamaith group. The Muslim politicians who are backing the said gynaecologist also prima facie supporters of such Jamaith groups.

Polarization is to corner the people that subjected genocide. Nazis polarized the Jews by detaining large numbers of Jews into detention camps and jails. Also, attacking and destroying cultural centres, places of worshipping or symbols followed by placing responsibility and accountability on the victims itself. Likewise, Muslim extremists have destroyed numerous Buddhist statues and temples, subsequently, placing the blame on the Opposition party. Also, many archaeological sites had been destroyed by Muslims and settled Muslim families with the blessings of powerful Muslim politicians.

Preparation is to build open prisons and build some sites for mass killing. This includes building infrastructure and developing the logistics. There are some evidence on training centres, collection and storage of sharp swords, knife and axes in countless mosques in great quantity. Communication system jamming equipment along with funds in the possession of Muslim extremist. Similar tactics had been used by Rohingaya Muslims against Myanmar Buddhists.

Extermination is the execution of genocide. In this stage, assassins believe that they are performing a holy matter by eliminating evils which will be reward by their interfaith. In this situation Muslim extremists believe that death amid a genocide is the road to heaven where they will receive 72 virgins. This had been reported in many international media in which Muslim intellectuals and scholars had not denied the beliefs.

Denial is to reject the acceptance of responsibility and accountability for genocide, putting the blame on others. This happened when large numbers of sharp swords, knives and axes were found in mosques. None of the top administrations of mosques could explain and give reasonable responses as to why large numbers of weapons had been stored inside the mosques. Powerful and responsible Muslim politicians gave devious answers in the media conference when the questions were raised. In the recent pass, after the Easter Sunday bomb attack by Muslim extremists at three Catholic churches and two prominent hotels; some Muslim corresponds and international media like BBC, CNN and Al Jazeera were blaming the Sinhalese Buddhist majority for the suicide bombings that killed circa 300 plus innocent people including more than 30 foreigners who had come to Sri Lanka. This is valid evidence that all powerful sectors had been infiltrated by Muslim extremists and that they handle the international media as they wish.

Have the gynaecologist applied the eight steps on Sinhala mothers?

The gynaecologist had easily classified and symbolized Sinhala mothers by their names. Dehumanization faith was followed by the gynaecologist, otherwise, he would not have been able to conduct such an inhuman act, which is depriving parents from having more than one child against their will. The gynaecologist had arranged all required facilities to perform sterilization while performing caesarean surgeries. Extermination had been adopted by way of conducting surgeries on Sinhala mothers very fast. Within fifteen minutes he had performed caesarean and had damaged the fallopian tubes of mothers.

Then

The numbers so far accused is circa 8000 and more than 500 complaints had been lodged within a week's time following the news. The receiving of complaints are ever increasing. There are some evidence that many other Muslim gynaecologists had been involved in genocide through the same method.

However, there is a prima facie suspect whether the Government will conduct a fair investigation against the Muslim gynaecologist due to the pressure and the influence of the powerful Muslim ministers.

Therefore,

We Sinhalese urged UNHRC to condemn the genocide assassins and black list all Muslim gynaecologists who will be proscribed by the Sri Lankan courts. Also, we Sinhalese urged UNHRC not to interfere with investigations against Muslim gynaecologists by way of putting pressure on the Government not inquiring sufficiently, to raise an issue or term the investigation as a threat to the minor group of people in the country and to support or listen to only some NGO's that have special interests of extremist clandestine terror groups etcetera. Also, Sinhalese urged UNHRC to appoint a panel to investigate impartiality of international media, especially the hate media against small countries and to take necessary steps not to deceive the listeners by such media giants.

Global Srilankan Forum Executive Committee, an NGO without consultative status, also shares the views expressed in this statement.
